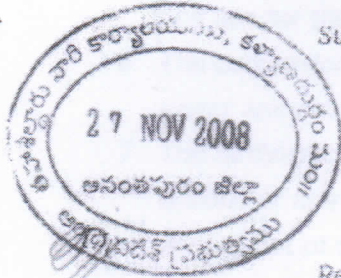

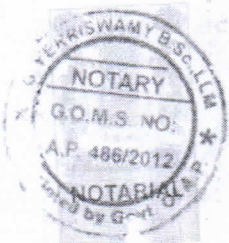
ORDERS:

Sri Ramesh Babu , Secretary, Gnana Bharathi Educational & Charitable Society , Kalyanadurg village of Kalyanadurg Mandal has applied for conversion of land from Agriculture land to Non Agriculture purpose under A.P. Agriculture Land(Conversion of Non-Agriculture purpose) Act-2006 in prescribed application in Annexure-'A', to an extent of 7.50 acres in 325-2 (1.60 acres) 325-3B (3.40) 325-2(2.50) acres of Kalyanadurg village of Kalyanadurg Mandal as he got title over the land as per the Document No.866/ dt.18.05.2001 and Document No.1340/ dt.11.05.2005.

The request of the applicant is found to be consistent with the provisions of the Act.

4. It does not confirm any right , title or ownership to the applicant over the above agricultural lands.






